

ALLIANCES Teton County Emergency Management Memorandum of Understanding (MOU) with Teton County, WY, the Town of Jackson and VOAD (Voluntary Organizations Active in Disaster)

AUTONOMOUS

While Teton County VOAD is an autonomous group of non-profits, community, and faith-based organizations that come together to help a community organize itself before disasters occur. We adhere to our Bylaws and Mission Statement “to foster more effective service to the people of Teton County affected by disaster.”

Teton County Emergency Management offers guidance to the Teton County VOAD along with the MOU (Memorandum of Understanding) with Teton County, WY and the Town of Jackson.

TETON COUNTY EMERGENCY MANAGEMENT (TCEM)

Our efforts are guided by and folded into the Teton County Emergency Operations Plan (EOP) and MOU (Memorandum of Understanding) with Teton County and Town of Jackson. We have been tasked by TCEM to identify missing services in the disaster plan, formulate a plan to mitigate, and let the public know what is needed. Our purpose is to communicate, collaborate, and organize these efforts so there is no duplication in services.

Emergency Managers have long known that disaster response, especially recovery, cannot be handled by the local, state, or even federal government alone. In order to get a community back onto its feet following a catastrophe, a coordinated response by government, non-profits, and volunteer organizations is crucial. Many states, counties, and communities across the country have achieved this coordinated response through Voluntary Organizations Active in Disaster (VOAD) groups. The mission of these groups is to bring varying volunteer organizations to the table in disaster planning. These groups volunteer to fill the voids in disaster services to best help the community in a coordinated manner.

The Teton County VOAD group was formed to assist Teton County Emergency Management in making Teton County better prepared for potential disasters. The goal of the organizations that belong to TC VOAD is to generate volunteers, guide them to the best organization or group where they can contribute their expertise.

An additional goal as we become prepared is to build resilience into our community’s disaster recovery scheme.

HISTORY: Founded in 1970

In response to the challenges many disaster organizations experienced following Hurricane Camille, seven national disaster organizations met to find a better way to coordinate their responses and be more effective. <https://www.nvoad.org/>

Since the founding in 1970, VOAD has grown to over 50 National Member organizations, plus State Members, and Partners throughout all 50 states, 4 territories and the District of Columbia.

They are guided by the “4 C’s” and work to fulfill the mission of a more effective service to people affected by disaster.

1. **Communication -** We maintain effective channels for sharing information and listen carefully to each other.
2. **Coordination -** We commit to work together, to utilize resources to accomplish a set of goals.
3. **Cooperation -** We need each other and recognize the value of working together with a common purpose.
4. **Collaboration -** Member Organizations establish shared goals and actively work together for preparedness and during disasters.

Up until then, numerous governmental, private sector and nonprofit organizations served disaster survivors independently of one another. Survivors were not able to access information on assistance and services available to them. There was little to no communication between the organizations wanting and trying to help.

Unnecessary duplication of effort often occurred, while other needs were not met. People wanting to volunteer to help those affected by the disaster were often frustrated by the variety of organizations helping in “some areas of service” or the total lack of opportunities to help other urgent needs. Training available to potential volunteers was limited, and without training, the opportunities to serve were limited during a disaster.

As an outcome, National VOAD shares knowledge and coordinates resources.....money, materials, and manpower.....throughout the disaster cycle.....working on preparation, response, recovery, and resiliency.

Mission

National VOAD is the forum where organizations share knowledge and resources throughout the disaster cycle – preparation, response and recovery – to help disaster survivors and their communities.

“The purpose of the corporation shall be to foster more effective service to people affected by disaster through communication, coordination, cooperation, collaboration, convening mechanisms and outreach.” – *National VOAD Bylaws* Core Principles -

“The purpose and objective of the Teton County VOAD shall be to foster more effective service to the people of Teton County affected by disaster through communication, coordination, cooperation, and collaboration with Teton County Emergency Operations Plan (EOP) directed by Teton County Emergency Management.”

- Teton County VOAD Bylaws -

Initial Objectives

1. Identify local volunteer/non-profit organizations interested in disaster preparedness, response, recovery, and mitigation.
2. Bring organizations together for an initial meeting to discuss the VOAD concept, create Vision/Mission statements, and set up regular meetings.
3. Once groups are identified and part of Teton County VOAD, let the community know which agencies are part of the VOAD, what their specialties are, and how they can volunteer and be a part of the Teton County Emergency plan before a disaster strikes.
4. Coordinate information from the Teton County VOAD organizations into the Teton County Emergency Operations Plan (EOP).
5. Guide volunteers to the correct agency for education. Report to TCEM updating the list of organizations and volunteers participating in VOAD to maintain a high level of readiness.

Ongoing Objectives


1. Build resilience into disaster recovery.
2. Regularly review adequacy of disaster services.
3. Make community aware of disaster preparedness.
4. Bring volunteer opportunities during disasters to the attention of the community.

Our work is to coordinate volunteer organizations prior to disasters.

The spreadsheet works by simply putting a “1” in a box that an agency has a capability in. It will turn the box blue, then tally the result at the bottom. The bottom is color coded based on the number of “1s” that it tallies up: **red means we don’t have any capability**, **yellow is median**, and **green are our highest capabilities**.
